HELD ON 21 APRIL 2020**

The Board is pleased to announce that the resolutions set out in the notice of AGM dated 19 March 2020 were duly passed by the Shareholders by way of poll.

Reference is made to the notice of annual general meeting of Beijing Capital Grand Limited (the “**Company**”) dated 19 March 2020 (the “**Notice**”). Unless otherwise defined, capitalised terms used in this section of the announcement shall have the same meanings as those defined in the Notice.

The board of directors (the “**Board**”) of the “**Company**” is pleased to announce that the resolutions set out in the Notice were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll at the annual general meeting of the Company held on 21 April 2020 (the “**AGM**”). The Company had appointed Tricor Investor Services Limited, the branch share registrar of the Company in Hong Kong, as scrutineer for the vote-taking at the AGM.

As at the date of the AGM, the total number of issued shares of the Company entitling the Shareholders to attend and vote for or against the resolutions at the AGM was 961,538,462. None of the Shareholders was required to abstain from voting in respect of the resolutions and there were no shares of the Company entitling the holder to attend and vote only against the resolutions at the AGM.
