This announcement is made by the Company pursuant to Rule 13.09(2)(a) of the Listing Rules and Part XIVA of the SFO.

The Board wishes to inform the shareholders of the Company and potential investors that it is expected that the financial results of the Group for the twelve months ended 31 March 2014 may experience a substantial decrease in net profit as compared to that of the corresponding year ended 31 March 2013.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Juda International Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “**SFO**”).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company and potential investors that based on information currently available in the unaudited management accounts of the Group, it is expected that the financial results of the Group for the twelve months ended 31 March 2014 may experience a substantial decrease in net profit as compared to that of the corresponding year ended 31 March 2013. Such estimated decrease was primarily attributable to a decline in gross profit margin for the twelve months ended 31 March 2014 as a result of the increase in the average purchase cost of the major raw materials purchased and decrease in average selling price of products sold by the Company.

As the Company is still in the process of finalising the financial results of the Group for the twelve months ended 31 March 2014, the information contained in this announcement is only a preliminary assessment by the Board based on the information currently available and the unaudited management accounts of the Group and is not based on any figures or information which has been audited or reviewed by the auditor or audit committee of the Company. Shareholders of the Company and potential investors are advised to refer to the Company's annual results announcement for the twelve months ended 31 March 2014 carefully, which is expected to be published on or before 30 June 2014.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
