CHANGE OF COMPANY NAME AND COMPANY LOGO, STOCK SHORT NAMES AND COMPANY WEBSITE

Reference is made to the announcement of Beijing Capital Juda Limited (formerly known as Juda International Holdings Limited) (the “Company”) dated 23 February 2015 and the circular of the Company dated 23 February 2015 (the “Circular”) relating to, among other things, the change of company name. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless the context requires otherwise.

CHANGE OF COMPANY NAME AND COMPANY LOGO

The board of directors (the “Board”) of the Company is pleased to announce that following the passing of the special resolution in relation to the change of company name at the AGM on 26 March 2015, the Certificate of Incorporation on Change of Name of the Company was issued by the Registry of Companies in the Cayman Islands on 26 March 2015 certifying that the change of name of the Company from “Juda International Holdings Limited 鉅大國際控股有限公司” to “Beijing Capital Juda Limited 首創鉅大有限公司” became effective on 26 March 2015. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 April 2015 confirming the registration of the new name of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the laws of Hong Kong). The logo of the Company has been changed to **CAPITAL  JUDA** upon the Change of Company Name became effective.

CHANGE OF STOCK SHORT NAMES

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “JUDA INTL” to “CAPITAL JUDA” in English and from “鉅大國際” to “首創鉅大” in Chinese with effect from 9:00 a.m. on Friday, 24 April 2015. The stock code of the Company remains unchanged as “1329”.

CHANGE OF COMPANY WEBSITE

The website of the Company has been changed from “<http://www.judaintl.com>” to “<http://www.bcjuda.com>” to reflect the Change of Company Name with effect from the date of this announcement.

EFFECT OF CHANGE OF COMPANY NAME AND SHARE CERTIFICATE

The change of the name of the Company will not affect any rights of the holders of securities of the Company. The existing certificates of securities in issue bearing the former name of the Company will continue to be evidence of title to such securities and the existing certificates of securities will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the existing certificates of securities for new certificates bearing the new name of the Company. Any new certificates of securities will be issued in the new name of the Company.
